Diginove now joins Mobilitas, bringing on board a portfolio of more than 60 customers from various high-tech sectors and 125,000 licenses. Within the group, Diginove will strengthen the physical and electronic records management division's offer, meeting customers' needs in terms of digital transformation for document processing.

TeleCense, Diginove's flagship satellite imagery project

Diginove has been working for several years on the TeleCense project, which aims to cross-reference satellite imagery with demographic data to facilitate decision-making by public institutions and private companies in terms of public policy and investment. TeleCense aims at becoming a significant player in the very promising market of geospatial data management. It should improve population estimates particularly in emerging countries where censuses are difficult to implement.

TeleCense has numerous applications: water treatment, electricity networks, real-time mapping of the coronavirus spread, industrial sites installation, etc. For example, Diginove is working with a large European insurance group on a project in Nigeria to anticipate the spread of certain diseases by crossing demographic and health data. Today, data and AI can enable better anticipation of health crises for insurance companies, but also contribute to the development of public health policies.

Mobilitas prioritises Diginove's international development

Within the French startup ecosystem, Diginove has already distinguished itself by winning the second "Innovation Contest" organized by BPI France. Diginove is also a member of Orange



Business Services' Cloud Starter program and a member of the European Space Agency (ESA) incubator.

With a turnover of €395,000 in 2020 and a very high R&D budget, Diginove is aiming for 50% growth in turnover in 2021/2022 relying on the arrival of Mobilitas in its shareholding to accelerate its development. Present in 97 countries worldwide, including the 54 countries of the African continent, Mobilitas will play a key role in winning new international customers for Diginove, particularly TeleCense applications for the African continent.

“The arrival of Mobilitas in Diginove's share capital is great news and a great opportunity for us”, said Michel Bénét Chariman and founder of Diginove. “It was important to find a partner capable of supporting our two activities, and Mobilitas fits perfectly into this dynamic”.
